

### Statistics on the career opportunities posted at CFA Montréal in Q1 2016


- Best first quarter since 2010 for the number of opportunities, 47. Positive shift witnessed in career opportunities since Q3 2015 continues.
- The Caisse de dépôt et placement du Québec, Investissements PSP and bcIMC (Victoria, BC) were the top 3 employers for this quarter.
- The investments and equity sectors accounted for close to 50% of the career opportunities in Q1. A level not seen since Q4 2014.

#### Number of career opportunities per quarter - CFA Montréal


